Chef Members - Red Ribbon of 'Disciples d'Auguste Escoffier'

● **Senior; (Sous-chef to Executive chef)**

Chef managing the kitchen of a Restaurant or a Hotel establishment. holder of a culinary diploma, and showing his/her determination to establish the French or International cuisine during his culinary career.

● **Junior; (commis to chef de partie)**

Chef active in the kitchen of a Restaurant or a Hotel establishment, showing his/her keen interest in the French or International cuisine and is eager to develop in the culinary career.

Must be introduced by a chef, who is a member of the O.I.D.A.E with a red ribbon.

Epicurean Members - Blue Ribbon of 'Amis des Disciples d'Auguste

● **Hospitality industry employee; (non-culinary professional)**

Employee of the hospitality industry, but not in the kitchen sector, such as General Manager, Maitre d'hotel, Chef de Rang or Sommelier etc. Showing his/her determination and keen interest in all areas of gastronomy during the ones career in the hospitality industry.

● **Epicurean; (non-hospitality industry professional)**

Person who has a strong interest in the all areas of gastronomy, but is not professionally linked to the hospitality industry.

Must be introduced by a chef, who is a member of the O.I.D.A.E with a red ribbon.

● **Honorary Member & Beneficiary: ;**

Honorary member who is a local, regional, or national French or foreign figure;

Beneficiary member who is in a corporate establishment, which is constantly supporting all activities of O.I.D.A.E. by continuously contributing to fulfill the objectives of O.I.D.A.E. or donating to the association.

Can only be nominated by the O.I.D.A.E. Chairman Board

Turns and conditions of the membership

● **In order to become an active member of the association, one must:**

- 1°) Be a respectable citizen and enjoy all civil rights;
- 2°) Be domiciled and/or be able to exercise one's professional activity in one of the departments of Asia. Constituting the Region;
- 3°) Adhere with the present statutes and with the disposals of the rules of procedure;
- 4°) To hold interest with the gastronomy, hotel and tourism industry;
- 5°) To engage oneself to the realization of the objectives pursued by the Association and to not abuse the membership for personal or lucrative gains;
- 6°) Formulate by written means an application for admission, signed by the applicant and followed by the signature of two sponsors, founding members and/or active members of the Association;
- 7°) Be authorized by the Mother Association, represented by O.I.D.A.E. Chairman Board, in which the decision in the matter is discretional and not prompted.

- **The association membership can be lost by:**

- 1°) The notified resignation by a registered letter with acknowledged receipt or by a letter given directly to the association's president;
- 2°) The death of actual member;
- 3°) The disablement, for whatever reason, of the corporate body, or of its declaration in a condition of rectification or judicial liquidation;
- 4°) The pronounced exclusion by the Order International des Disciples d'Auguste Escoffier's board members, Mother Association, or by the association's Administrative Council, for serious intentions such that the offences to the present statutes or the association's rules of procedure, or, by not paying annual fees, the concerned party having beforehand been invited to offer his or her means of defence.
